

# PRIVACY POLICY FOR THE PROTECTION OF PERSONAL DATA WITHIN THE SCOPE OF THE WEB SITE

## INTRODUCTION

This Privacy Policy for the Protection of Personal Data within the scope of the Website
describes the treatment that SIDS provides to the personal data it collects from the users of
our Website. This policy complies with the provisions contained in the Personal Data
Protection Law, Law No. 29733, its Regulations and the Information Security Directive issued
by the competent authority.

### **DATA COLLECTION**

2. Para efectos de visitar nuestra página web usted no tiene la obligación de proporcionar datos personales.

However, in cases where you access services provided by SIDS through such means, or participate in events promoted by SIDS, among others, it is possible that SIDS may require specific and necessary personal information for such purpose. Such information may include name, last name, cell phone number and email address. Likewise, when the nature of the request so requires, and as long as it is strictly necessary, SIDS may request other personal data.

## **USER'S CONSENT**

3. The completion of the forms required by our website for access to services or participation in events promoted by the SIDS, represents the express consent of the owner for the collection of personal data and its processing for the specific purposes for which it was collected.

#### RESPONSIBILITY FOR THE INFORMATION PROVIDED

- 4. Personal data provided by the user must be, under his responsibility, true, complete, accurate, current and correspond to his true identity.
- 5. Any kind of damage or harm, direct or indirect, arising for SIDS or third parties as a consequence of the partial or total breach of the obligation referred to in the previous point, shall be the sole and exclusive responsibility of the user who provided the information.

## **INFORMATION PROCESSING**

- 6. Personal data provided will be processed only for the specific purpose for which they were provided.
  - PEID shall not use the user's personal data for any purpose other than that expressly provided for in this Privacy Policy, unless it is a purpose expressly permitted or required by the applicable legislation in force or unless SIDS has previously obtained the user's consent.
- 7. PEID will not share or transfer to third parties any personal data of the user without prior consent.



8. PEID website may offer links to other websites that are not part of those. It is the user's responsibility to check the privacy policies of such websites to verify the level of protection of his/her personal data in that environment, which is beyond the responsibility of PEID.

9. PEID reserves the right to modify its Privacy Policy for the Protection of Personal Data in the Scope of the Web page as well as the notice through which it discloses it, in order to adapt it to the changes that may be required by the current regulatory framework.
